Message from the Executive Director

Information is Power

The ARTA officers and members are continually learning from our members. One of the things we found at the area meetings this past spring was that there was a misunderstanding of the statesponsored health coverage for Medicare-eligible retirees. Most of us have referred to this coverage as a "supplement" to Medicare. In reality, the correct wording is "secondary" to Medicare.

Medicare supplements are offered by insurance companies and are government standardized. ARBenefits is a "self-funded" group, not an insurance company. Therefore, it is not a true supplement and is not government standardized. As a "self-funded" plan, ARBenefits has the discretion to include or exclude services.

School retirees who are on Medicare and have this secondary coverage pay only \$100.78 a month for the plan. This premium is de-

ducted from their ATRS check and is often substantially less than supplemental premiums.

All Medicare retirees are reminded to ask providers if they have checked with their secondary coverage before having any procedure. It is beneficial for the member to remind the provider if their coverage is "secondary" not a "supplement".

The ARBenefits secondary plan also includes a hearing allowance (\$1400 per ear every three years) and all ARBenefits plans cover air ambulance service, provided it is medically necessary.

Contact information for EBD, which administers the ARBenefits plans, is listed in every issue of the INTERLINK. You may also want to call one of the ARTA sponsored insurance representatives. They are licensed and trained to answer any questions you may have about Medicare coverage. Their contact information is also listed in every copy of the INTERLINK.

In pension news, the Joint Legislative Committee on Retirement and Social Security Programs will be holding 10 meetings around the state in September and October. The directors of the five public state retirement systems will make presentations. If you live close to a meeting, it would be worth your time to go hear from the ATRS Director, Clint Rhoden, and to meet the legislators on the committee.
