# Message from the President

## Happy New Year

Happy New Year to all I have not seen this year! Welcome to ARTA in 2016! Can you imagine the ARTA year is half over? As I write this, we have just completed the ARTA Winter Board Meeting and I am happy to report that we are off to a good start. January brings with it thoughts of beginning anew, setting new goals/resolutions and recommitting to old ones. We, in AR-



TA, will continue working on the membership goals set in 2014. Yes, this is a new month in a new year, and we ask you to help us resolve the *old membership gap* – one of our most important ongoing goals.

The number of public school retirees and their membership in the local units and in ARTA, the state organization, is still much too low. This gap weakens our strength at the local and state levels. And we have yet to close the dual membership gap. We have some retirees affiliated with the local units and some with the state, but not enough in both organizations. We need your help to unify the organizations and close the membership gaps. As of December 1, 2015, we had 72,539 active public school employees. There are 42,889 retirees and survivors who receive some type of benefit from the Arkansas Teacher Retirement System (ATRS). However, *of the 42K retirees*, only 12, 299 belong to ARTA, the state organization, and just under 7,500 belong to the 65 local RTA units. We have much work to do to get the dual memberships to fifty percent or higher. Several local units have turned in their membership reports for the mid-year. However, we are waiting for the membership reports from all units to determine the amount of growth from September, 2015 until January, 2016.

Would you join us in resolving to make membership your primary focus? Continue to ask non-member public school retirees to join at the local and state levels. Resolve now to work to recruit members to close the membership gap. Resolve to not stop asking until you get a member to join. Put into practice "every member gets a member". Share with potential members why you are a member of the local unit and ARTA, and all the benefits you have received. Let them know that ARTA is the parent organization and it is the only professional organization that works for the benefit for all retired public school employees. Joining ARTA sends a clear message to legislators, neighbors, and businesses alike, that retired public school employees are important and vibrant members of our community. Collectively, you make ARTA's/RTA's presence known through volunteer efforts in the area in which you live as well as through legislative advocacy in the statehouse.

Finally, as ARTA members, we must continually work to increase our membership. If each of us would contact two or three retirees and get them to join as dual members, what a difference it could make at the local and state levels. There is strength in numbers. Can we count on you? Will you do your share? Can we make this an unforgettable year of change and growth in dual membership? Can we close the membership gap? Can we eliminate the gap? *Do not forsake ARTA, and ARTA will continue to work for all public school employees/retirees, and not forsake you.* 

I hope to see you this spring as I visit the six area meetings throughout the state. Go, grow and glow in your county and in the state. Make ARTA/RTAs shine in your community and in our state.

The Sheriff's Ranch is located outside of Amity. They had six



## Arkansas Teacher Retirement System (ATRS) Board of Trustees Election

Election of the following two (2) positions on the ATRS Board of Trustees will take place in March 2016:

### Position #9 (Member Trustee—Retirant Trustee)

Candidates for Position #9 must meet the following criteria:

- 1. Retirant member of ATRS.
- 2. Resident of the State of Arkansas.
- 3. In accordance with A.C.A § 24-7-301(6), an employee working for the system is not eligible to be elected or appointed to the board, or a candidate to be elected or appointed to the board.

Eligible voters for Position #9 shall be all retirants of ATRS, regardless of present employment status or residency.

### Position #2 (Member Trustee—2<sup>nd</sup> Congressional District) Candidates for Position #2 must meet the following criteria:

- 1. Employed by a participating employer located in the congressional district for which he or she is seeking election.
- 2. Active Member of ATRS (Includes T-DROP Participants).
- 3. Minimum of five (5) years of actual service.
- 4. Employed in a position that requires a state teaching license or the equivalent.
- 5. In accordance with A.C.A § 24-7-301(6), an employee working for the system is not eligible to be elected or appointed to the board, or a candidate to be elected or appointed to the board.

Eligible voters for Position #2 shall be active members, regard-

less of credited service, employed by participating employers located in the respective congressional districts and who are employed in a position that requires a state teaching license or the equivalent.

The Board of Trustees shall employ an independent contractor who will mail ballots to eligible voters' addresses on record and will also collect, count and certify election results.

- Ballots mailed: Tuesday, March 15, 2016
- Deadline for ballots to be returned: Friday, April 15, 2016
- Results Certified: Wednesday, April 20, 2016

If a candidate receives at least 50% of the votes cast on the first ballot, he/she will be declared the winner of the election and will assume office on July 1, 2016. If a run-off election is necessary, the candidate receiving at least 50% of the votes cast will be declared the winner of the election and will assume office on July 1, 2016.

The term of office for each elected trustee is six (6) years. Each trustee shall continue to serve as trustee until his or her successor is elected.

If no candidate received at least 50% of votes cast by eligible voters on the first ballot, a run-off election will be held between the two (2) candidates receiving the highest number of votes for the position.

# Legislative News

## Election Season Lasts All Year

By the time you read this, Arkansas will have participated in what is being called the SEC Primary. Within a few more months, many political races will have narrowed considerably. While some of you may already be experiencing election fatigue, others may feel you have plenty of time to research a candidate. The fact is, this is an excellent time to contact both current and potential elected officials.

Your Arkansas Congressional Delegation should be hard at work through the spring. Most are fairly responsive to their constituents, whether you are encouraging them to vote for or against a bill or simply sharing your thoughts on an issue. We've listed their Washington D.C. contact information, although they also have local offices for your convenience. All delegates except for one are running for reelection in 2016.

The Arkansas State Legislature will meet for a Fiscal Legislative Session, and possibly a Special Legislative Session this spring, but will likely not take up any other legislation this year. Attention will instead turn to fall, when 17 Senate seats and all 100 House

seats will be up for reelection. Note that many of these races are uncontested, making for a few less candidates to contact.

We encourage you to use the next few months to contact or meet with your elected officials as well as with those who are running for office. Learn about where they stand on issues that are important to you by attending their meetings or inviting them to yours. You can also request a one-on-one meeting to share information with them on issues where you may be more knowledgeable than they are, such as retirement, pensions, or Medicare, to name just a few. Regardless of your political affiliation or your personal ideology, the goal is to develop a relationship with them now, ahead of their election or the next legislative session.

Please also let the ARTA leadership know what concerns you have as a retired school employee. While ARTA can not endorse a particular candidate, we can continue to advocate for legislation that benefits all retirees. We will also continue to encourage and support you in your efforts to do the same. If we can provide information or other assistance, please let us know.

# Up, Up and Away!

"Up, up and away..." goes the popular song of the 1970s and that's the way it was at the Albuquerque International Balloon Fiesta as hundreds of hot air balloons of all sizes, colors and shapes took to the cloudy New Mexico sky.

My wife, Mary Ann, and I were witnesses of the "sunrise mass ascension" at the fiesta which was held October 3-11, 2015. We were on a trip with members of the Arkansas Retired Teachers Association that traveled from Sherwood to Albuquerque and Santa Fe, New Mexico via Oklahoma City (OK) and Amarillo, Texas.

That morning the weather was cool and the sky was overcast. There was very little breeze at Balloon Fiesta Park, a facility that has to be large enough to handle all of the balloon participants, not to mention thousands and thousands of spectators and the vehicles they arrived in. Still, the desert air was filled with excitement as balloon crews readied their craft for inflating and ascent. As that was going on, streams of headlights could be seen from all directions as carloads and busloads of people arrived for the event.

Because of the weather conditions, the event was under the vellow flag for what seemed a long time before conditions changed and the green for go flag was hoisted and things began happening.

The balloons were spread out on the park. Burners were lit, gaspowered fans were started and the tasks of inflating the balloons began. Festival officials said about 600 balloons were supposed to fly that morning.

It was still not daylight, but kind of twilight as the burners flared, both lighting up and inflating the balloons, causing them to stand upright. The flames inside made them glow in the predawn light. As the balloons were inflated, the crowd cheered, anticipating the mass liftoff.

It is called the Dawn Patrol Show, which as been a part of the fiesta since 1978. The Dawn Patrol Show is not only beautiful but practical. Dawn Patrol pilots take off before sunrise and fly until landing sites become visible, giving other balloonists an idea of wind speeds and direction at different altitudes.

## My Tropical Costa Rica

November 5, 2015 a group of ARTA travelers arrived in San Jose, Costa Rica after about a six hour flight. The following day, after a short bus ride through the beautiful countryside, a tour of the Doka Coffee Estate allowed us to see the complete coffee process including all the machinery and workers involved from "seedling" to the "final" beans in a bag. Later we traveled to the

Guanacaste Region for lodging at the hotel RUI. The hotel is encompassed on three sides with almost 30 acres of fenced rain forest (the fencing keeps animals out.) The fourth side faces a sandy beach with crashing waves and beautiful blue water with the ocean temperature in the seventies. Many took advantage of the nice beach and warm waters for the rest of the afternoon. Sunday we experienced Monteverde Cloud Forest for a nature walk through a spectacular ecosystem of flora and fauna (trees, bushes, vines, flowers, etc. for us novices).

While in Monteverde we went to Selvatura Park, a cloud forest reserve, visiting butterfly gardens and hummingbird galleries with more than 100 hummingbirds. Our next exciting and enjoyable adventure was a leisurely-paced guided walking tour above the

forest floor crossing several "hanging" bridges that were long and very high. That afternoon, several of us "brave folks" did the Zip Line above the canopy consisting of twelve cables from 120 feet to 3,600 feet long and from 60 to 400 feet above the ground. This is among the best things I have ever done!


On Tuesday, November 10<sup>th</sup>, we cruised Lake Arenal, the largest

lake in Costa Rica. The scenery on shore was absolutely beautiful and we got to observe lots of waterfowl and see the huge Arenal Volcano which has produced lava for the past 30 years. The next day we took a river boat trip in Cano Negro getting to see numerous waterfowl, monkeys, turtles, lizards and even caiman providing some good photo opportunities. Our last day was spent with a visit to land-

scaped parks and shopping.

For those who like trips where you can walk quite a bit, this is a wonderful trip with tour guides who are very knowledgeable and provide you with a very memorable trip.
