active legislation that poses a threat to our retirement system. There are, however, several shell bills that have been filed but have not been filled out. We are watching these to keep track of their development.

I want to express my appreciation to our ARTA members for their effort in distributing ARTA posters in all our schools. These materials explain AR-TA's mission, who it represents and how it can impact retirement. The posters are intended to introduce active employees to ARTA and encourage their later membership.

ARTA's strength lies in its numbers. Without new membership, over time our association, by attrition, will fade away. I am therefore respectfully asking for all area directors, associate directors and unit presidents to emphasis the importance of securing monies to fund scholarships for current classroom teachers in Arkansas. Reaching out to active teachers will show recipients and their peers firsthand what ARTA is doing for education in Arkansas. Message from the Executive Director

The Sky is Not Falling!


Do you remember the children's story about The Little Boy Who Cried Wolf? The boy Peter alarmed his community so often that a wolf was going to attack that when he *was* attacked, no one came to his rescue. How about the story of Chicken Little, who shouted "The sky is falling, the sky is falling!"?

Now there are groups on Facebook and elsewhere that continue to stir the pot about the futures of the Arkansas Teacher Retirement System and the Arkansas Public Employees Retirement System. After one group posted the misleading line last summer that the state was ending all public retirement systems, I received calls from family members and many retirees, in tears and at the point of heart failure, because they could not survive without their ATRS pension benefits. More recently, a group has been asking for people to send them money to take the fight to the state legislature and the governor. This sounds like a dubious scam to me. Likewise with signing their online petition, which allows them to capture your personal information. This is not the way to treat people, nor is it the way to effectively influence legislation.

Please do not let the rumor mill control your lives. This only leads to fear, anxiety, wringing of hands and sleepless nights among retired as well as active public-school employees. Please don't spread hearsay about our retirement system, members of the Arkansas Legislature or the Governor. If you do have concerns, do some fact-checking. Call, email or visit with your elected representatives and the governor's office. Call, email or visit with your representatives at ARTA and ATRS (remember that four of the 11 ATRS trustees are also members of ARTA). As Will Rogers put it, "Rumor travels faster, but it don't stay put as long as truth". Let's work together in positive ways to maintain the promise of great pension and insurance benefits for everyone who has been or is currently a public servant in Arkansas's public schools.

ARTA needs every member to stay engaged in the process of citizen involvement at the local, state and federal levels. We need to ALL be on the same page, sharing the same talking points and factual information. Information is not only knowledge, it is power.

Here are your talking points to share with the governor's office and elected state representatives:



- Tell them you are a member of the Arkansas Retired Teachers Association and that you vote.
- Thank them for serving in the legislature.
- The Arkansas Teacher Retirement System is working efficiently, with a member-elected board and four trustees appointed according to their position (Commissioner of Education, State Treasurer, State Auditor and State Banking Commissioner). Do not change the composition of the ATRS Board. Allow the ATRS Board to do the job they were selected to do.
- Share your concern in a positive manner.
- Try to get them to voice a commitment to support the position you stated.
- Thank them either way and leave on a positive note.

It does take the whole village of ARTA to reach the 135 members of the House and Senate. The important point is that you live in their district and are a voting constituent. Every vote counts! Can ARTA count on you? All public-school retirees and active employees are counting on you to really step up your game instead of crying wolf. The sky falls on all of us if we do nothing.

As the Irish statesman Edmund Burke stated, "Nobody made a greater mistake than he who did nothing because he could only do a little".

Team ARTA is counting on EVERY team member.

ARTA Board Announces Changes to Awards Program

INDIVIDUAL ACHIEVEMENT AWARD

- The award criteria does not change.
- This award will become an area-level award.
- The next Individual Achievement Awards will be given at the 2020 Spring Leadership Conferences.
- Recipient photos and nomination information may be submitted to ARTA for inclusion in the INTERLINK.

MEMBERSHIP AWARDS

- Awards will be given based on the membership growth reported by local units during the ARTA membership campaign (Fall-Spring).
- In 2019, the Membership Committee and the ARTA staff will coordinate to determine awards to be given at the Annual State Convention.
- In 2020, membership awards will be presented at the Spring Leadership Conferences and subsequently reported in the INTERLINK.

UNIT ACHIEVEMENT AWARDS

- The revised criteria for this award will be shared with incoming local presidents at the 2019 Spring Leadership Conferences.
- Select awards may be given at the 2019 Annual State Convention as units become familiar with the new criteria.
- The first awards using the new criteria will be given at the 2020 Annual State Convention.

COMMUNITY SERVICE AWARDS

The Community Service and Public Relations Committee is working separately to review and revise the criteria and forms for the Community Service Awards.

VOLUNTEER HOURS

Volunteer hours will still be reported in the annual reports to ARTA. Cumulative hours and individual hours over 1,000 will be published in the INTERLINK.

ANNUAL REPORT FORMS

The annual report forms have been revised to incorporate the changes made to the ARTA awards program. These forms will replace the existing forms in the spring of 2019.
