# Message from the President

### Politics 101

My goals as president of ARTA have been to increase the growth of ARTA membership, to have more transparency and to focus on an identity for our association. In order for this to happen, you as members need to know how ARTA operates and its functions so you can have input, make suggestions and offer your leadership in helping ARTA develop its identity.



Personally, this was my first time to be involved with a legislative session. I did not feel comfortable because of my lack of experience but was told to rest assured, there was no legislation on the horizon that would affect our retirement system. My first hurdle was in November when I learned that George Hopkins, executive director of the Arkansas Teacher Retirement System, had resigned. Most of you know, respect and admire Mr. Hopkins for his leadership of ATRS.

The second hurdle occurred when Gail Stone, executive director of the Arkansas Public Employees Retirement System was replaced by the APERS board of directors. I learned that unlike the ATRS board, which is elected by its members, the present members of the APERS board are appointed. More apprehension – could this happen to the ATRS board? We do not need to change the method by which members of the ATRS board are elected.

Another hurdle came when bills on retirement matters started appearing. Most of the proposals focused on APERS retirees, but what happens in one retirement system could happen in others. Still APERS, not ATRS, was on the chopping block. Then a bill was introduced that included ATRS. It would adjust COLA increases from three percent (3%) to an adjusted cost of living index. This had the potential to reduce retirement benefits for future and present retirees. Stress levels escalated. I have always held myself accountable for any actions that happened when I was in charge of a school and now our association.

Every Monday for eight weeks I attended the meetings of the Joint Committee on Public Retirement and Social Security Programs along with other ARTA officers and members. It was not until week nine that the committee finally shut the door. This legislative session was concluded with no changes to your retirement benefits.

I would urge you to avoid becoming complacent. There will be another legislative session in less than two years. Similar bills will probably come up again.

I want to give my sincere thanks and appreciation to the following: Clint Rhoden for his leadership as the new executive director of ATRS; Jeff Stubblefield, chairman of the ATRS Board of Trustees, , ATRS board members who were present at nearly every meeting; Donna Morey, executive director of ARTA; Charles Tadlock, ARTA legislative committee chair; all of the ac-

ARTA members and *all* Arkansas retired public school employees should be thrilled that the 2019 General Assembly did not make any changes to their Arkansas Teacher Retirement System benefits. The Joint Committee on Public Retirement and Social Security Programs worked very diligently, using common sense for the common good this session. If one of your elected officials served on the Joint Committee, please take time to thank them for their service.

Each Joint Committee meeting was attended by ARTA officers and many ARTA members, who kept close contact with the workings of the committee. Thank you, ARTA members for your personal contacts and attendance at the capital.

No further legislative changes can occur to the ATRS until the 2021 general session. There will be Legislative Committee meetings in the interim to discuss the different public retirement systems in Arkansas.

Spring stayed busy for ARTA with eight Area Spring Leadership Conferences. It was a pleasure to visit with ARTA members who chose to attend these meetings. The meetings are always full of information for retirees, and an opportunity to network and fellowship with friends living in other communities. A big thank you to the ARTA area directors, associate directors and area leadership councils for

planning and presenting the area programs.

The ARTA year of service is from July1-June 30. The ARTA officers have represented the membership tirelessly this year at

the ATRS Board of Trustees meetings, at the Joint Committee meetings at the capital, and some of the state-sponsored insurance meetings with the Employment Benefits Division of the Department of Finance and Administration.



Being an ARTA officer is too often a thankless job. President Bob Thompson took the responsibility for leading the organization very seriously, serving countless hours and driving many miles to represent ARTA members. He helped ARTA refocus on helping active public school teachers by highlighting the Parsons-Burnett Scholarship Program, as well as the Clark County

active teacher grants. He also inspired the creation of posters explaining the acronyms of ARTA, ATRS and EBD with a space for local units to share their own contact information and encouraged board members and directors to place them in all public schools. ### ARTA Expands Scholarship Program

The ARTA Board of Directors voted to expand the Parsons-Burnett Scholarship for 2019. ARTA will now award up to eight scholarships of \$2,000. In addition, scholarship checks will now be presented to recipients at their school or district, rather than at the annual convention.

The purposes of these changes are to a) increase support for practicing educators in Arkansas public schools to further their education and b) increase awareness of ARTA among active teachers before they retire.

The changes to the program were made in response to ARTA president Bob Thompson's encouragement to tell active school employees more about AR-TA and to let them know that ARTA supports them not only in retirement, but now as well.

The Parsons-Burnett Scholarships are funded by memorials and donations from members and their families. Contributions to the scholarship fund may be sent to ARTA at any time.
